

# Terms & Conditions of the NEF-NEF Homeware™ mood-board platform competition

**1. Competition.** NEF-NEF SA, Industrial & Commercial Company, based at Dalias Street, No. #5, in the area of Acharnes, Attica, PC 13677, (hereinafter the "Organizer") announces a competition entitled "NEF-NEF Homeware™ Mood Board Platform" (hereinafter the "Competition"), which will be conducted through the official website of the company at NEF-NEF.gr and the webpage: <http://www.nef-nef.gr/decor> (hereinafter the "Website").

**2. Right to Participate in the Competition.** The right to participate in the competition have only those who reside permanently in Greece and are over 18 years old.

**3. Exclusion of Contestants/Participants.** All those who fall into the following categories / cases are excluded from the Competition: (a) all types and levels of Executives, the Management and Direction bodies and all the Employees of the Organizer, (b) the persons of first degree kinship with the above under (a) employees, executives and management/direction bodies and their spouses, (c) all types and levels of Executives, the Management & Direction bodies and the Employees of the advertising firm, JNLeoussis+ (d) the persons of first degree kinship with the above under (c) employees, executives and management/direction bodies and their spouses.

**4. Duration of the Competition.** The duration of the Competition is defined as the period from 01/06/2020, time 12:00 p.m. (hereinafter the "Start of the Competition"), until 30/06/2020, at 23:59 p.m. (Further "Completion of the Competition").

**5. Registration to the Competition.** The Competition will be conducted through the official website of the Organizer, "www.NEF-NEF.gr", and specifically through the webpage: <http://www.nef-nef.gr/decor> (hereinafter the "Website"). In order to participate in the Competition, participants must visit the above website page, accept the terms and conditions of participation and submit their basic contact details by registering, either through their personal account on Facebook (Facebook login), or through registering their Name and Surname, and Email address (E-mail login). To participate in the Competition does not require the purchase of any of the products traded by the Organizer.

The submission of the above information and the acceptance of the Terms & Conditions presented in this document, constitutes a declaration of participation in the Competition, without any charge or further procedure. The personal data submitted will be kept by the Organizer, or assigned third parties (JNLeoussis+), on behalf of the Organizer, will constitute full proof regarding the receipt of any participation in the Competition and the validity of this participation, according to the Article 7 below. It is noted that multiple creations (mood-boards/collages) are allowed, but for each user there will be one (1) participation entry in the Competition per Email or Facebook ID.

**6. Gift.** The competition Gift(s) (hereinafter the "Gift" or "Gifts") that 5 lucky winners will win by change, after registering to participate in the competition, will be determined via a lucky-draw lottery process, and is the following: One (1) pc. per winner, of the ORVILLE throw for armchair.

The Organizer is entitled to determine, in its sole discretion, the specific individual features of the Gift provided.

The Gift is personal, and the winners of the Competition do not have the right to choose the Gift they have won. They also do not have the right to exchange gifts with money, or other products or things. The value of the Gift is variable.

**7. Determine Competition's Winners.** The winners of the Competition will be announced by the process of a lucky draw sweepstake. The specific lucky-draw process will take place on 01/07/2020 via a computer connected to the Internet, at the offices of the Advertising Company JNLeoussis+. All valid entries will be submitted to participate in this lucky-draw to determine the 5 winners who will win the specified Gifts. "Valid participation" as above means any participation in the Competition for which the following applies cumulatively: (a) a valid participation has been submitted in accordance with the procedure described in Article 5 above, (b) does not constitute, in its sole discretion by the Organizer, product of illegal and/or technical influence, or in general fraud, or unlawful interference of the participant or third party, and (c) has been submitted and registered via the above Website, within the time period determined as Start of the Competition until the End of the Competition, as defined in Article 4 above.

**8. Update on the Award - Receipt of Gifts.** The data of the winners of the Competition (Name & Surname of the Winners) will be announced on the Official Page of the Organizer on Facebook, and also the winners will be informed by the Organizer with a relevant personal message via Facebook and/or by a personal message via E-mail.

In case, for any reason, it is not possible to communicate directly with any one of the winners announced from the lucky-draw stage of the Competition (5 winners) within a period of three (3) calendar days, from sending to him/her a relevant written personal message (via Facebook Messenger & via E-mail), or someone from the winners of the Competition, despite the fact that his/her name/surname is posted on the Organizer's Facebook page, does not contact for any reason (including health, lucky and/or force majeure) with the Organizer, within the above time period, the specific person permanently loses his/her right to the relevant Gift and the position of the winner will be passed over, to the first runner-up, in the order their name emerged from the lucky-draw process, and so forth.

**9. Responsibility.** Participation in this Competition requires access to the Internet by the participant's own technical means. The Organizer undertakes no obligation regarding the provision, assistance of access to the websites, or the provision of facilities to any interested party. The Organizer does not bear any responsibility, in case the contact details provided by each and any participant, and of course by any winner, via Facebook registration or via E-mail registration, are incorrectly typed and/or registered, or untrue, and therefore communication with him/her is not possible. or this is completed with a longer delay, beyond the expected waiting period announced for the communication of the winners with the Organizer (3 working days), as well as in case the winner, for any reason, does not respond and does not claim his/her Gift, within the specified 3-day period, for any reason, and as stated above he/she will lose his /her right to receive the Gift and the replacement emerged will take his/her place. Furthermore, the Organizer reserves the right to cancel any or all entries, in the event that there is a reason for exclusion, under Article 3. Also, the Organizer bears no responsibility for any modification of these terms, or the revocation of the Competition, as set out prior and below. After the completion of the Competition, any obligation of the Organizer ceases to exist, and the latter does not bear any further responsibility towards any of the participants/contestants to the Competition.

**10. Publicity.** The terms & conditions of participation to this Competition are posted on the above Website page ([www.nef-nef.gr/decor](http://www.nef-nef.gr/decor)). In any case, all participants can and must resort to review these terms, always, to be informed in case of any future modifications.

**11. Personal Data.** The provision of personal data (such as name, surname, and e-mail) are declared and stated in writing by the participants themselves, during the registration process to participate to this competition, and only if they wish to do so, on their own initiative, in order to participate in the lucky-draw process and have the possibility to be one of the 5 winners who shall win one (1pc.) of the specified Gift, in accordance with Article 6 above. We have implemented the appropriate security measures for registration of personal data, and we use the appropriate information systems, the software, and all our procedures are up to date, in order to ensure that the Personal Data Participants will remain safe throughout the course, and at the end of this competition. It's the Organizer's right to keep safely stored and secure the personal data of the competition Participants, for as long as it takes to serve the above purpose (Competition), as well as to send informational and promotional messages to them via E-mail (newsletters), for as long as this is permitted under applicable law.
